## HELPFUL HINTS FOR APPLICANTS

### Who Can Apply?

Any society, association, charitable trust or organisation that is incorporated or legally constituted, and whose rules do not allow money, property, or any other benefits to be distributed to any of its members.

### What Can Be Applied For?

Funds are available for any charitable purpose that benefits the Community and is in accordance with the Objects of the Auckland Softball Foundation Charitable Trust, the full detail of which can be seen in the Trust Deed on the website [www.asfct.org.nz](http://www.asfct.org.nz)

In brief these purposes are:

- \* To encourage pupils and students and the public at large to play softball;
- \* To provide lectures, demonstrations and coaching of softball;
- \* To provide facilities and equipment of every kind related to the playing of softball;
- \* To enhance the development of the game of softball throughout New Zealand.

All grants must be used for goods and services within New Zealand.

### Will The ASFCT fund multi-year projects?

The Foundation will only fund multiple period projects if the full amount of the project through to completion is applied for in the initial application and the ASFCT had those full funds available at the time of application.

### What Detail Is Required In The Application?

The ASFCT will require sufficient detail so as to be able to ascertain how the project fits within the 'plans' for your organisation and how benefits will accrue to your organisation. It will be important to show how the success of your project is going to be measured.

### What Sort of Resolution is Required?

A typical resolution would be along the lines of:- "It was resolved that an application be submitted to The Auckland Softball Foundation Charitable Trust for funding of \$xxx, towards the cost of....."

A copy of the resolution is then certified by the Secretary or other authorised signatory as being a true and correct copy extracted from the minutes of the Organisation.
